## 3. Composition/information on ingredients

## 4. First-aid measures

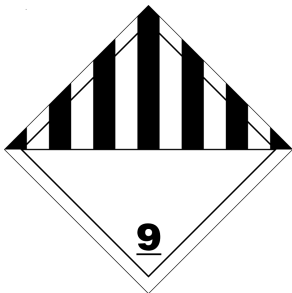

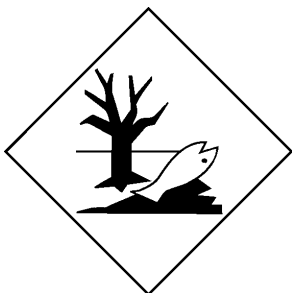
